## GENERAL INTRODUCTION TO THE TRAINING PROGRAMMES

Allama Muhammad Iqbal, who proposed a separate homeland for the Muslims of the Subcontinent, stressed the need for the establishment of institutes for research on Islam. The chief function of such institutes, according to him, should be 'to mobilize the dormant spiritual energy of the younger generation by giving them a clear grasp of what Islam has already achieved and what it has still to achieve in the religious and cultural history of mankind.' Need for such research was, however, felt more intensively after the independence of Islamic Republic of Pakistan and the adoption of the Objectives Resolution as the ideological framework of the country's constitution. The need to know and explain Islam in depth and to work out its implications for human thought and action in the present-day world was, therefore, self-evident. It is imperative that scholars of Islam engage themselves in serious study and research in the fields of Qur'anic Sciences, Hadith, Islamic Law and Jurisprudence, History, Culture, Philosophy, Tasawwuf, and other Islamic disciplines of social sciences. It is important not only to review their developments in the past but also draw a blueprint for future developments of Muslim thought in order to meet the requirements of the contemporary Muslim societies in a rapidly changing world.

In the light of this rationale, the Constitution of the Islamic Republic of Pakistan of 1956 under article 197 speaks about Islamic Research Institute as under:

"197-(1) The President shall set up an organization for Islamic research and instruction in advanced studies to assist in the reconstruction of Muslim Society on a truly Islamic basis."

In accordance with this constitutional requirement the Central Ministry of Education, Government of Pakistan formed an organising committee to establish the

institute. This organising committee on March 04, 1958 passed the following resolution in defining the objectives of the Institute:

This Institute will be concerned with the study of Islam and its civilization and culture and will promote research in all branches of thought and learning in which Muslims have distinguished themselves in the past and which are of the importance to them in present-day conditions in order to assist in the construction of Muslim Society on a truly Islamic basis.

The content of the article 197 of the Constitution of the Islamic Republic of Pakistan 1956 was retained in article 207 of the Constitution of 1962.

In pursuance of these constitutional provisions Islamic Research Institute (IRI) was established in 1960 to develop a methodology for research in various fields of Islamic learning, identify and study contemporary problems, and interpret the teachings of Islam in order to elaborate the Islamic tradition in the modern and contemporary context. The Institute has the tradition of conducting serious research. The research accomplished at the Institute is published in books, monographs, reports, and research journals. The Institute also organises seminars, conferences, and workshops.

The Institute prepared a large-scale training programme of the researchers in 1962. In the training programme, the researchers were to be trained in various languages as well as Islamic and contemporary sciences so that they could contribute in the research activities of the Institute. However in the past, these training programmes could not be launched as permanent feature of the institute. In view of the significance of the training, the Council of Islamic Research Institute in its 11<sup>th</sup> meeting held on October 27,

2017 approved the following three permanent training programmes of the Institute:

- (1) Undergraduate Training on Research and Technical Writing;
- (2) Postgraduate Training on Academic Research and Scientific Writing; and
- (3) IRI International Postdoctoral Fellowship

It is hoped that these training programmes will elevate the researchers to a position where they would better understand all dimensions of the Islamic thought, history, and culture. Equipped with such training, these researchers will be able to conduct and produce their own research independently. Furthermore, these training programmes will contribute in preparing a cadre of researchers for the promotion of quality research.

## UNDERGRADUATE TRAINING ON RESEARCH AND TECHNICAL WRITING

### INTRODUCTION

In the light of the raison d'être of the Islamic Research Institute, the Undergraduate Training on Research and Technical Writing is designed to impart basic training in research writing. This programme will train students for technical writing at an early stage of their academic career. The aim of this training is to equip them with fundamental skills of research and technical writing. Moreover, they would be introduced to research tools, so that they could articulate their thought with in certain theoretical framework. Finally, this training shall be useful for them when they embark on serious research in their graduate and postgraduate degrees. Hence, the Institute is launching one-week Undergraduate Training on Research and Technical Writing for the students of various Pakistani universities.

### OBJECTIVES OF THE PROGRAMME

This programme is designed to provide foundational concepts related to technical writing, which is essential for any research activity. It will focus on undergraduate students who are embarking on journey of creative learning and research with nominal or no exposure to research methodologies. The training programme aims at incorporating foundational requirements for technical research writing. This training

programme will further focus on capacity building of the students related to writing skills and technical editing of their research work. It will also be helpful to the students for all types of writing such as preparation of assignments, projects and examination papers.

### ELIGIBILITY FOR REGISTRATION OF UNDERGRADUATE TRAINING PROGRAMME

The applicant must have completed 12 years of education (F.A/F.Sc/A level or equivalent) and should be enrolled in any undergraduate programme at IIUI or any other university.

### DURATION OF THE TRAINING PROGRAMME

The training programme is one-week long, in which the students will attend training workshops five hours per day. The training sessions will be held at Islamic Research Institute, International Islamic University, Faisal Masjid Campus, Islamabad.

### PEDAGOGICAL APPROACH

The training format would be a combination of various pedagogical techniques such as lecturing, interactive sessions, group discussions, presentations, and teamwork on short projects.

## UNDERGRADUATE TRAINING ON RESEARCH AND TECHNICAL WRITING

In these sessions, the participants will be provided with opportunities to express their own views and knowledge related to technical research writing. The final phase of the training will be of an applied nature. In this part, the participants will be divided into various groups. These groups will be asked to collect data on any topic of their interest and demonstrate their writing skills.

Once ready for conducting foundational research, students will be asked to produce a piece of research and technical writing by applying the techniques and methodologies of research that they have learned during the training programme.

### MODULES OF THE TRAINING PROGRAMME

The training will consist upon following modules:

- Day 1: Orientation and Capacity Building
- Day 2: Research Discourse and Academic Writing
- Day 3: The Structure of a Creative and Scientific Essay
- Day 4: Application of Paragraph Methodology in Writing Process
- Day 5: Data Collection, its Tools and Methodologies

### CERTIFICATION

On full participation and successful completion including submission of take-home assignments, participants will receive a testimonial certificate as recognition of their completion of the training.

# POSTGRADUATE TRAINING ON ACADEMIC RESEARCH AND SCIENTIFIC WRITING

## INTRODUCTION

A three-level academic research and scientific writing training has been specifically designed for postgraduate researchers. The purpose of this training programme is to prepare a cadre of researchers for the promotion of quality research. The main focus of the postgraduate training is to equip students with modern techniques of research writing and applied research methodology. This training will enhance the understanding of researchers in a broader perspective where they would be able to differentiate between academic writing and non-academic writing while conducting their own subject-based research. Management and organisation of research are the key elements in taking up any research project. This training programme will significantly enhance researchers' abilities in these fields.

## OBJECTIVES OF THE TRAINING

This programme has been designed to delineate and solve the problems related to the application of appropriate research methodologies in various types of researches that are conducted in humanities and social sciences in general and Islamic theology, law, Islamic thought, history, culture and civilization in particular. The training also aims at building the capacity of the researchers for research design, data collection, writing skills, and technical editing of the research work.

The trainees will also be prepared to follow specific guidelines while doing their research. The guidelines such as Chicago Manual of Style, Publication Manual of the American Psychological Association, and MLA Style Manual etc. will also be introduced.

## ELIGIBILITY FOR POSTGRADUATE TRAINING PROGRAMME

### Level 1:

- (i)-16 years of education (i.e., BS 4 years, LLB/MA/MSC or equivalent)
- (ii)-Admission in any MS/LLM/PhD

programme of IIUI or any other university

### Level 2:

- (i)-16 years of education (i.e., BS 4 years/LLB/MA/MSC or equivalent)
- (ii)-Admission in any LLM/MS/PhD programme of IIUI or any other university
- (iii)-Completion of Level 1 of IRI Postgraduate Training Programme

### Level 3:

- (i)-16 years of education (i.e. BS 4 years/LLM/MA/MSC or equivalent)
- (ii)-Admission in any LLM/MS/PhD Programme of IIUI or any other university
- (iii)-Completion of Level 1 and Level 2 of IRI Postgraduate Training Programme

Note: The student who completed one week training workshops titled "training workshop on research designs, data collection techniques, writing skills and technical editing for production of quality research" (2015-2016) can be enrolled in level 2.

## DURATION OF THE TRAINING PROGRAM

These three levels will be completed in three workshops. Each workshop will be of one week. During the gap between two training workshops, the trainees will be required to complete specific research tasks at home. The trainees would remain in contact with their respective faculty advisors at the Institute. The methods of distance learning will also be used for that purpose. The whole programme will be completed in one year.

## PEDAGOGICAL APPROACH

At the beginning of the training, theoretical framework would be explained to the participants. In this part, they will be informed about various kinds of writing techniques. In second stage, interactive sessions of the participants will be arranged to allow them brainstorm with reference to their writing-skill aptitude and knowledge and to assess their research capacity.

The training will be divided into the following three levels:

### **LEVEL-1:**

#### **ORIENTATION AND CAPACITY BUILDING**

In this level, the theoretical framework of the training would be explained to the participants. They will be introduced about various kinds of research and its methods. They will also be particularly informed about the relevant literature of classical Islamic period in which classical methods of research have been used.

### **LEVEL-2:**

#### **ACADEMIC WRITING AND ARTICULATION OF RESEARCH**

After the completion of the theoretical framework in level 1, the interactive sessions of the participants will be arranged in the second level of the training. In these sessions, the participants will be provided with opportunities to express their own views and knowledge about the research. Level 2 of the training will be of applied nature. The participants will be divided into various groups. These groups will be asked to collect data on certain topics and prepare outlines for research. In this part, the opportunities of the application of various research techniques will be provided to the participants. Finally, each student or group of the students will be asked to prepare a design of a short project aimed at producing quality research. This project will be assigned to them as their future activity.

### **LEVEL-3:**

#### **TECHNICAL EDITING AND PRODUCTION OF QUALITY RESEARCH**

In this level of the training, the trainees will be prepared to produce quality research. They will be provided with an opportunity of the technical editing of the research that they have completed in the second level. As the outcome of this level, the complete research of the trainees would be submitted for publication to a journal or a thematic volume of IRI.

Following are the details of each level with their specific training modules:

### **Modules for Level-3: Technical Editing and Production of Quality Research**

- Day 1: Introduction to the Art or Methodology of Editing
- Day 2: Manuals of Style
- Day 3: Introduction to Research Journals
- Day 4: Publication Process of the Research
- Day 5: Presentation of Research Articles and Closing Ceremony

## **CERTIFICATION**

---

The duration of this training programme is one academic year. Each level of the training is independent. Transfer to the next level is contingent upon satisfactory research activity during the time period between the two levels. In case a trainee would not want to continue to the next level, a certificate of the particular level that the trainee has completed will be issued. On completion of each level, a separate certificate and transcript will be issued. The candidates who will complete all three levels of the training shall receive a testimonial diploma as recognition of their completion of the programme.
